As part of a collaboration agreement on Seveso activities that ISPRA (Italian National Institute for Environmental Protection and Research) has with the Italian Ministry of Environment, an activity of organizing events for the exchange of bilateral experiences between member countries is planned. The first event will be related to "Integrated Safety Studies for Seveso establishments". It will address several topics, such as assessing the domino effect in areas with a high concentration of industrial establishments, along with the related issues of external emergency planning and urban and regional planning, starting with the consideration of the data and information contained in the notification form, and also to exchange experiences with all the interested administrations. It will involve multiple Member States (Belgium, Finland, Italy, Sweden), making it a multilateral event, with the local (Regional Environmental Protection Agency - ARPA, Regional Fire Brigade, Port Authority, Prefecture, and interested municipalities) and national (Italian National Institute for Environmental Protection and Research - ISPRA, Ministry of Environment - MASE, National Fire Brigade - CNVVF, National Institute for Insurance against Accidents at Work – INAIL), administrations involved.
